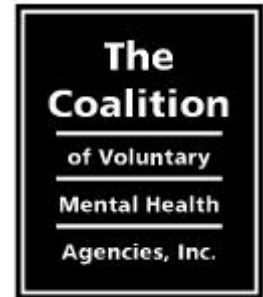

State budget on a rapid slide to completion: COLA/trend is in

State legislators from both houses are working furiously to complete the budget--by mid-next week, according to some speculation. Mental Hygiene Sub-conferees have met publicly and reported their work to the general Budget Conference Committee. While language has yet to be published, bills have yet to be passed and all results are subject to final negotiation, here is what is being presented to the full committee:

Mental Health is slated to receive \$24,170,500, a full 44% of the mental

hygiene spending of \$55 million.

COLA Rally is huge success

On Monday March 30 over 1,200 Human Services workers from all over New York State descended upon Albany to show the flag for a cost of living adjustment (COLA) they have long been denied. The day began in the Legislative Office Building where posters were handed out, logistics were planned and rally participants practiced chants for the afternoon's rally. After a sun-drenched lunch in East Rock Park the crowd moved to the steps of the Capitol.

The scene was inspiring as demonstrators overflowed the Capitol steps and surrounded the statue at their base. Waving signs and chanting "C-O-L-A Give our workers better pay," the energy level was very high. Speakers from the dozen human services coalitions from around the state brought cheers from the exuberant crowd.

After the rally we split up into smaller groups to pay visits to some legislators.

It seems that the day's efforts were not in vain. Early word from Albany is encouraging. Keep an eye on this space for more information. □

Re-authorize Homeless Services

The legislation creating the New York City Department of Homeless Services is sunseting on June 30, 1998. The Coalition is working to ensure that the Department remains a permanent part of the city's human services landscape. □

Yet more merger matters

Legislation creating the new NYC Department of Public Health - merging DOH and DMHMR&AS - has been introduced to the City Council and assigned to the Committee on Government Operations, chaired by Councilwoman Mary Pinkett (D-Bklyn). Though the committee has two hearings scheduled in April, the bill (Int. 266) has not yet been added to the agenda of either hearing.

The bill names the merged department the Department of Public Health, not Department of Public Health, Behavioral Health and Disabilities Services, the designation preferred by The Coalition. The legislation creates a division of mental hygiene services consistent with Mental Hygiene Law requirements for a local governmental unit. Heading this division will be a deputy commissioner who will have the powers of a director of community services. A mental hygiene advisory board will serve as a community services board, advising the commissioner and the deputy commissioner, and will have subcommittees for mental health, mental retardation/developmental disabilities, and alcoholism and substance abuse. □

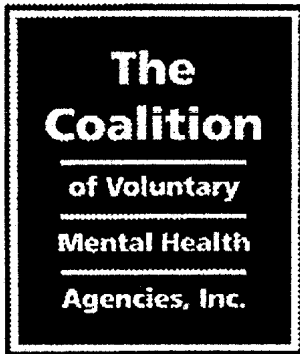
