## Unfinished business (and lots of it)

On Thursday, June 22<sup>nd</sup> the 2000 legislative session in Albany ended. Legislators returned home to prepare for party conventions and gear up their campaign machines. Unfortunately, before they left Albany they failed to pass some key pieces of legislation for which the mental health community had been pushing.

### ***Work and Wellness Act of 2000***

In order to benefit from the Federal Work Incentives Improvement Act (WIIA), New York State must pass implementing legislation. The Work and Wellness Act of 2000 would remove one of the primary barriers preventing people with disabilities from joining or rejoining the work force. Currently Medicaid benefits are cut off completely when a person with a disability earns too much. The WIIA would enable people to buy in to Medicaid on a sliding scale based on their income level. The mental health advocacy community has joined with advocates for people with physical disabilities and people with HIV/AIDS to push for passage of this law. On June 5<sup>th</sup> the Assembly unanimously passed its version of the law, sponsored by Brooklyn's Assemblyman James Brennan. The Senate bill, sponsored by Staten Island's Senator John Marchi, never made it to the floor for a vote.

On Wednesday, June 21<sup>st</sup> The Coalition joined in support of a rally that brought nearly 200 people to Albany to make a final push to encourage Governor Pataki to push a law that he has publicly supported in principle. At that rally nine people with physical and mental disabilities and HIV/AIDS were arrested for handcuffing themselves to Governor Pataki's door. Unfortunately, even this level of commitment and anger failed to con-

## SNPs to sunset shortly

On June 30, 2000 the legislation authorizing Mental Health Special Needs Plans (SNP) will sunset. All of the other parts of the HCFA 1115 waiver authorization were extended for three years as part of the budget process in order to recognize the savings in the bill. The section of the legislation related to SNPs, however, was not included in the blanket reauthorization. The legislative session has concluded without agreement on how to extend the SNP authorizing legislation, so the years of hard work and preparation will not come to fruition with mental health SNPs.

On June 13<sup>th</sup> the Assembly passed a one-year extension of the authorizing legislation with a requirement for an independent actuary to study the methodology used to construct the RFP. On June 14<sup>th</sup> the Senate passed a three-and-a-half-year extension with a similar requirement for an independent actuarial analysis. Neither bill included the financial protections The Coalition felt were critical to ensuring the viability of the community-based system. The Coalition, which represents community-based organizations that were members of both winning and non-winning SNP bidders remained concerned about risk to the field as a whole, but was hopeful that a compromise could be reached that would move the SNP process forward and protect providers at the same time. We are disappointed that an agreement was not reached.

In spite of the difficulties that the past six weeks of negotiations have engendered, The Coalition believes that there was much of value in the SNP concept. We hope to continue to work with OMH and our elected leadership to organize care and identify new ways to redirect inpatient money to rehabilitation and recovery programs for people with severe mental illnesses. ©

## OMH reorganizes

The New York State Office of Mental Health (OMH) has reorganized some of its operations in order to better meet the agency's top priorities of **A**ccountability, **B**est Practices and **C**oordination. The main realignment is of operations resources into a Division of State Psychiatric Center Management (under Al Holmes) and a Division of Community Care Systems Management (under Linda Rosenberg, CSW). In addition, all quality assurance and clinical issues will be moved to the Office of the Chief Medical Officer. ## Mission accomplished

An embarrassment of riches was presented to attendees of *Mission for the 21st Century: Employment Services for People with Mental Illness*. The June 20th conference highlighted how much skill, talent and passion can be brought to bear on the problem of unemployment among people with psychiatric disabilities. Philip Saperia provided the welcoming remarks and discussed the ambitious goals of the New York Work Exchange which are to provide training, technical assistance, information and research to improve vocational outcomes for community-based mental health agencies.

State Office of Mental Health Commissioner James Stone and City Department of Mental Health, Mental Retardation and Alcoholism Services Commissioner Neal Cohen lent their considerable clout to the conference and the undertaking by joining us to present their vision for the future, one in which unemployment rates for peo-

ple with mental illness are no higher than for anyone else. International Association of Psychiatric Rehabilitation Services COO Ruth Hughes gave a motivating keynote speech on the pitfalls of adopting a single model. She provided research and evidence to demonstrate that different clients need different types and levels of support. Pope Simmons and Edwin Lopez-Soto did an excellent job guiding the group through the complexities of crucial federal legislation and regulations: the American with Disabilities Act (ADA), Workforce Investment Act (WIA) and Ticket to Work and Work Incentives Improvement Act (TWWIIA)

The afternoon was similarly compelling. Panel presentations demonstrated the breadth of interest and expertise we have in New York City. Panels responded to the vision laid out by the two Commissioners, addressed ways to manage symptoms in the workplace and provided the crucial consumer perspective.

We are very grateful to the presenters who expended so much time and energy to put together such excellent presentations and to all of those who joined us. We look forward to continuing to work together to accomplish our mission. ©

vince the Governor to move. The Medicaid Buy-In coalition has, however, vowed not to disappear quietly. Rallies and demonstrations are being planned for the entire summer.

## Mental Health Insurance Parity

Once again New York State's legislature has failed to end our state's tacit approval of discrimination by insurance companies against people with mental illness. Despite the best efforts of long-time parity champion Jim Brennan to move the bill more expeditiously than ever this year, the Senate has once again stood in the way of non-discriminatory insurance. The Assembly passed its parity bill unanimously, very early, on January 24th. The Senate, on the other hand, failed to do the same.

Despite the tremendous efforts of advocates who lined up two-thirds of the Republican Senate majority as co-sponsors, when the procedural votes to bring the bill to the floor for a vote were cast, they fell strictly along party lines, with the majority ending the bills chances.

Advocates do not plan to be quiet about this major gap in the civil rights of people with mental illness either. Along with the long-time picnics for parity, the picket for parity has been added to the advocacy arsenal. Expect more of them.

## Presumptive Medicaid Eligibility

When a New Yorker with a mental illness is released from jail, prison or a State psychiatric facility s/he is ineligible for Medicaid for at least the 30-90 days the application process takes. This critical period of transition back into the community is the worst possible time to be without health care coverage. For decades this bureaucratic barrier has prevented people from accessing the care they need resulting in countless costly relapses. The recently enacted Assisted Outpatient Treatment law would provide medications during this period, but does not have a mechanism to cover treatment or rehabilitative care.

The Coalition has worked very closely this year with allies from the Urban Justice Center and Correctional Association to address this problem. Efforts to include it in the budget were stymied, but this campaign also will not end with the session. ©

- 88% feel they have privacy in their living arrangements.

## Going the wrong way

The MTA has published a revised half-fare application that is so badly flawed it may throw the whole program off track. The current application informs physicians that in order to get half-fare benefits, SSI recipients must be unable to work. Not only is this requirement not included in the statute, it directly contradicts the intention of the law, to enable people with psychiatric disabilities to return to work. We are working to have the application changed.©

## 103 psych meds in pipeline

On June 20<sup>th</sup> the Pharmaceutical Research and Manufacturers of America (PhRMA) released the results of a survey indicating that 103 new medicines are currently being developed to treat mental illnesses. Of those 26 are aiming at depression, 24 are focused on Alzheimer's, 16 have set sights on schizophrenia and 13 are targeted at anxiety disorders.
